BAC Resolution Declaring a Single Calculated Responsive Bid Resolution No. 2017-021

WHEREAS, the SCIENCE AND TECHNOLOGY INFORMATION INSTITUTE advertised the Invitation to Bid (ITB) under Competitive Bidding for the project, "PHASE 3: PRE-PRODUCTION, PRODUCTION AND POST PRODUCTION OF DOSTv SCIENCE FOR THE PEOPLE CONTENT" at the G-EPS website for seven (7) days;

WHEREAS, in response to the said advertisement, only one (1) bidder purchased the bidding documents;

WHEREAS, during the scheduled bid opening, *TENORIUM ENTERPRISE* was the lone bidder;

WHEREAS, **Tenorium Enterprise** presented first and foremost a Platinum Membership Certificate to the PhilGEPs which is now a basic requirement yet highest standard of eligibility;

WHEREAS, the rest of the required certificates are complete showing their original and/or certified photocopies. The BAC requested the TWG on Broadcast & AV Production to submit a report and recommendation immediately after executing the post qualification and evaluation;

WHEREAS, the BAC finds that the **TENORIUM ENTERPRISE** was compliant with the technical and financial requirements:

WHEREAS, **TENORIUM ENTERPRISE** has completed the Phase 2 of DOSTv project (*Packaging of DOST-Developed and Supported Technologies and Innovation for Broadcast and Digital Promotion through DOSTv: The Filipino Weather Channel*) with STII this year, there has been actual experience with the crew and other creative personnel assigned for DOSTv. The working mechanism between Tenorium and DOSTv – STII personnel has been in place and already in practice;

WHEREAS, the TWG found out that the Net Financial Contracting Capacity (NFCC) of *TENORIUM ENTERPRISE* was computed at K = 10 value which amounted to Php 23,093,350.00. The NFCC was supposed to be computed at K = 15 value which will

amount to Php 34,640,025.00. The re-computed amount nonetheless, did not affect the eligibility of **TENORIUM ENTERPRISE** and made them even more qualified for the project.

WHEREAS, the TWG finds the bid proposal of **TENORIUM ENTERPRISE** responsive to the needs of the end-user and hereby recommends the awarding of contract to the said bidder;

NOW, THEREFORE, we the Members of the Bids and Awards Committee (BAC), hereby RESOLVE as it is hereby RESOLVED to request the BAC Secretariat to prepare the Notice of Award (NOA) and Notice to Proceed (NTP) to **TENORIUM ENTERPRISE**.
