



BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) FOR THE PROJECT "SUPPLY, DELIVERY AND INSTALLATION OF 1 LOT 40-FOOTER CONTAINER VAN PROPERTY STORAGE FACILITY AND 20-FOOTER CONTAINER VAN I.T. BACK-UP FACILITY."

WHEREAS, the DOST-SCIENCE AND TECHNOLOGY INFORMATION INSTITUTE advertised the Invitation to Bid (ITB) for the project "**Supply, Delivery and Installation of 1 Lot 40-Footer Container Van Property Storage Facility and 20-Footer Container Van I.T. Back-Up Facility**" with an Approved Budget for the Contract (ABC) of One Million Seven Hundred Seventeen Thousand Pesos Only (Php1,717,000.00) in the DOST-STII website, the PhilGEPS website and conspicuous places at DOST-STII premises for seven (7) days;

WHEREAS, a Virtual Pre-Bid Conference was conducted on 23 November 2023 at DOST-STII CAST Room, wherein four (4) prospective bidders attended the conference, namely:

1. RANGATIRA TRADING CORPORATION;
2. SHOCK AND AWE INDUSTRIAL CORP.;
3. VASTCON ASIA CONSTRUCTION INC.; and
4. H&I COMPANY

WHEREAS, the Bids & Awards Committee (BAC) has scheduled the deadline for submission of bids and virtual bid opening on 07 December 2023 at 10:30 AM;

WHEREAS, during the scheduled submission and opening of bids, out of the four (4) bidders who bought the official bidding documents, two (2) of them were able to submit their bids on-time, namely:

1. RANGATIRA TRADING CORPORATION; and
2. VASTCON ASIA CONSTRUCTION INC.;

WHEREAS, the chronological order of the opening of bids was based on the date of the submission of the bids, the sequence is as follows:

1. RANGATIRA TRADING CORPORATION; and
2. VASTCON ASIA CONSTRUCTION INC.;

WHEREAS, during the scheduled Opening of Bids, the envelope 1 containing the eligibility and technical components of the two (2) bidders were opened. The TWG and BAC members carefully examined all the components of envelope 1, as a result, the following has been observed:

WHEREAS, the financial component envelope of the two eligible bidders who both passed the preliminary examination of the technical and eligibility requirements were opened and, consequently, the BAC read and recorded their financial bids as follows:

WHEREAS, upon evaluation and validation of the bids submitted, the BAC declared RANGATIRA TRADING CORPORATION as the Lowest Bid As Read (LBR) in the amount of Php1,393,198.76;

WHEREAS, the TWG conducted the thorough evaluation and post-qualification assessment on the submitted bids. As a result, the following has been observed:

NOW, THEREFORE, We the Members of the Bids and Awards Committee (BAC), hereby RESOLVE as it is hereby RESOLVED:

- That **RANGATIRA TRADING CORPORATION** be declared as the Lowest Calculated and Responsive Bid (LCRB) in consideration of its total amount of bid equal to **ONE MILLION THREE HUNDRED NINETY-THREE THOUSAND ONE HUNDRED NINETY-EIGHT PESOS AND 76/100 ONLY (Php1,393,198.76)**;
- That, a Notice of Award (NOA) be issued to **RANGATIRA TRADING CORPORATION**, upon the approval and effectivity of General Appropriations Act (GAA) for FY 2024; and
- To recommend for approval by the HoPE/Director of the DOST-Science and Technology Information Institute (DOST-STII) the forgoing findings.
